Heard Mr. B. Chakraborty, learned counsel appearing for the petitioner. Also heard Mr. D. P. Borah, learned Standing counsel, Health & Family Welfare Department.

Pursuant to the last order dated 07.11.2024, Mr. D. P. Borah, learned Standing Counsel, submits that he has received instructions from the Health & Family Welfare Department, Dispur, Guwahati-6 by letter dated 28.12.2025.

Perusal of the instructions indicates that the following steps are undertaken: -

“1. The draft Service Rules in respect of Assam Dental Services have been prepared and endorsed to Personnel Department along with the relevant justification for necessary Concurrence as required under the extant procedure.

2. The draft Rules include provisions relating to promotional avenues, study leave, placements, and job responsibilities of different cadres of Dental Surgeons, along with justification thereof.

3. It is further submitted that the matter relating to creation of posts of Dental Surgeons has also been taken up separately and is currently under examination by the Personnel Department for necessary concurrence.”

Let a detailed affidavit be filed, incorporating the aforesaid instruction and indicating the time frame within which the entire exercise will be completed.

Relist the matter on 23.03.2026.
