Heard Shri SRA Naser, learned counsel for the petitioner. Also heard Shri SS Roy, learned State Counsel and Shri BP Sarma, learned counsel for the respondent nos. 2 and 3.

Vide an order dated 29.01.2026, this Court had called for the records connected with the Award. Accordingly, the records were requisitioned by this Office.
