Heard Mr. S. Dutta, learned counsel for the applicants. Also heard Mr. M.P. Goswami, learned Additional Public Prosecutor for the State.

This I.A.(Crl.) has been preferred seeking suspension of the sentence of 5

years rigorous imprisonment imposed by the impugned judgment and order dated 12.04.2024 passed by the learned Sessions Judge, Karimganj, in Special NDPS Case No.171/2022 under Section 20(b)(ii)(B) of the NDPS Act and to allow the petitioner to go on bail.

It is submitted that the applicant has already undergone more than 3 years 3 months imprisonment, which is more than half of the sentence imposed.

In view of the above, it is directed that the remainder of the sentence shall stand suspended and the applicant shall be allowed to go on bail on furnishing a bail bond of Rs.50,000/- with two sureties of the like amount to the satisfaction of the learned Trial Court/Jurisdictional Court.

I.A.(Crl.) is disposed of accordingly.
