Case taken up before the Lawazima Court.

Learned counsel Mr. R.S. Chauhan appears on behalf of the petitioner. Heard.

Learned counsel Mr. N.R. Sarma appears on behalf of the learned Standing counsel, BTC, representing the respondent Nos. 5 & 6. Heard.

Perused the records.

Perusal of the recent office note dated 17.02.2026 reveals that the notice was issued to the respondent No. 7 by way of speed post with A/D mode on 04.02.2026.

But so far, it appears that neither the A/D card nor any un-served notice has been

received in regard to the above mentioned notice issued to the respondent No. 7.

However, it appears that the postal track consignment report regarding the above mentioned notice has been generated and the same has been annexed with the case record at **Flag-'Z' in the Part-III file**. Now, a perusal of the said postal tracking report reveals that notice in respect of the respondent No. 7 has been delivered on 12.02.2026.
