2. Alleging wilful and deliberate non-compliance of order dated 15.09.2025 passed in WA No. 151/2025, the petitioner has filed this contempt petition under Sections 11 & 12 of the Contempt of Courts Act, 1971 read with Article 215 of the Constitution of India.
