Mr. V. Rajkhowa, learned counsel for the petitioner and Mr. D. Nath, learned Senior Govt. Advocate are present.

2. The incident of police firing took place on 25.01.2018 and till date the investigation of the case is pending and not brought to its logical conclusion despite communication by the Superintendent of Police based on the instructions from the DGP to complete the investigation within a time bound manner.

3. In the interest of an early investigation, the Court is inclined to direct the learned Senior Govt. advocate to have a scanned/ photocopy of the case diary made and the original case diary be returned forthwith to the Investigation Officer.

4. We also direct the learned Senior Govt. advocate to have a consultation with the competent and responsible authorities in the Assam police

to inform the Court as to the tentative time that may further be required for completion of the investigation.

5. If a reasonable timeline is not provided, the Court would be compelled to pass an appropriate orders on the next date of listing.

6. The learned Senior Govt. advocate shall send a downloaded copy of this order to the competent authority to obtain instructions preferably within 01.09.2025.

7. List this matter again on 02.09.2025 preferably at 3.30 PM.
