Heard Mr. V. Rajkhowa, learned counsel for the petitioner. Also heard Mr. D. Nath, learned Senior Govt. Advocate, assisted by Mr. H.K. Hazarika, learned Govt. Advocate.

2. Pursuant to the order dated 16.10.2025, the learned Senior Govt. Advocate has produced a copy of written instruction dated 03.11.2025, received from the Assistant Inspector General of Police (Law), thereby informing that Maibang P.S. Case no. 02/2018 was charge-sheeted vide Maibang P.S. Charge-Sheet No. 19/2025 dated 30.10.2025 under section 120(B)/143/144/145/147/148/332/333/353/ 435/307/188/34 IPC, read with section 3/4 of the PDPP Act against 06 (six) accused persons, namely, (1) Shri Bishal Hojai, (2) Smti. Surodi Thousen, (3) Smti. Alpana Langthasa, (4) Shri Sunujit Sengyung, (5) Shri Thangsen Langthasa, and (6) Shri Thaisring Hojai.

connection with Maibang P.S. Case No. 06/2018, before the Court of learned District & Sessions Judge, Dima Hasao, Haflong has been annexed.

4. A copy of the said letter along with the Final Report/ Charge Sheet has been provided to the learned counsel for the petitioner.

5. The learned counsel for the petitioner has submitted that he has sought for certain instructions from the petitioners, who reside at an interior part of the district of Dima Hasao. Accordingly, he prays for some time.
