Heard Mr. U.C Rabha, learned counsel for the petitioner, Mr. A Ali, learned counsel for the Election Commission of India, Mr. J. Payeng, learned counsel for the State of Assam appearing for the Foreigners Tribunal and Border Affairs as well as Ms. G Sarma, learned counsel for the authorities under the Union of India.

Issue notice to the respondents except the respondent No.4 returnable in six weeks.

Call for the LCR of Case No.F.T 86/2017 from the Foreigners Tribunal No.1, Barpeta.

In the meantime, the petitioner shall neither be detained nor be deported. The petitioner shall submit two separate surety bonds from two prominent persons of her village or a security from an appropriate Government official to the satisfaction of the Superintendent of Police, (Border) Barpeta to ensure continuous presence of the petitioner as and when required by the authorities, who shall also verify the authenticity and acceptability of the sureties.
