Heard Mr. R. Boro, learned counsel for the petitioners.

The petitioners are aggrieved by the action of the respondent Union Bank of India, Dhubri Branch. According to the petitioners, the Branch Manager, Dhubri Branch, Union Bank of India has kept certain amount in the bank accounts of the petitioners on hold. The petitioners have projected that the action is on the basis of certain cyber complaints with which the petitioner had no relation.

Having regard to the nature of projection made, this Court is of the view that at this

stage, notice is to be issued to the respondent no. 3 only. The notice is made returnable on 01.04.2026.

The petitioners shall take steps for service of notice upon the respondent no. 3 by speed post, within 3 [three] working days from today.
