Heard Mr. B.M. Deka, learned counsel for the petitioner. Also heard Mr. P. Borthakur, learned Additional Public Prosecutor, Assam appearing for the State

respondent.

This is an application under Section 482 of BNSS, 2023 praying for grant of pre-arrest bail to the accused/petitioner, namely, Afridi Khan @ Cream who is apprehending arrest in connection with an unregistered case of Abhayapuri Police Station.

It is submitted by the learned counsel that the petitioner has the apprehension of filing any FIR against him by one Rejina Easmin. It is further submitted that it is a fact that the present petitioner has some relationships with said Rejina Easmin but when he came to know that she married thrice before the relationship with the present petitioner, he tried to convince his family members but at that relevant time only, she started blackmailing him and even made some nude photographs of the petitioner made viral. Mr. Dekka further submitted that later on the petitioner came to know that one G.D. Entry has already been made vide GD Entry No.20, dated 30.01.2026, in the Abhayapuri Police Station, Bongaigaon. Accordingly, it is submitted that some interim protection may be granted to the present petitioner till receipt of the police report from the concerned police station.

Mr. P. Borthakur, the learned Additional Public Prosecutor, Assam submitted in this regard that the report may be called for at this stage, without providing any interim protection.

Considering the submissions made by learned counsel for both sides, the petitioner is provided with some interim protections. Accordingly, no coercive action shall be taken against the petitioner till receipt of the report from the

concerned police station.

Accordingly, report be called for from the Abhayapuri Police Station, Bongaigaon as to whether any case has been registered against the present petitioner.

List the matter on 06.03.2026, for the police report.
