Heard Ms. A Bujarbaruah, learned counsel for the applicants.

The applicants have instituted the present Interlocutory Application praying for impleading "The District Scrutiny Committee" as respondent No. 8 in the connected writ petition, being WP(C) No. 5103/2024.

It is submitted that while filing the connected writ petition, the said District Scrutiny Committee was referred in the body of the petition as respondent No. 5. However, inadvertently, the said respondent was not arrayed as a respondent in the cause title.

It is submitted that the office has, thereafter, rectified the cause title and the numbers assigned to the respondent Nos. 6, 7 & 8 have been rectified and renumbered as respondent Nos. 5, 6 & 7.

Accordingly, it is projected that the present Interlocutory Application was necessitated to be filed for impleading the earlier respondent No. 5, now as respondent No. 8 in the connected writ petition.

The prayer made by the applicant is not objected to by the learned counsel for the respondents.

In view of the above, the applicant is permitted to implead "**The District Scrutiny Committee, Lakhimpur District, represented by its Chairman, the Deputy Commissioner, Lakhimpur, Assam, Pin-787001**" as respondent No. 8 in the connected writ petition, being WP(C) No. 5103/2024.

With the above observations and directions, the present Interlocutory Application stands disposed of.
