Heard Mr. A. M. Khan, learned counsel appearing for the applicant. Also heard Mr. S. S. Roy, learned CGC.

By way of this application, the applicant is seeking impleadment of (i) the Director General, ITBP, Delhi Headquarter, Block No. 2, CGO Complex, Lodhi Road, New Delhi-110003, (ii) the Inspector General North-East Frontier Headquarters, ITBP, Itanagar, P.O.-Khating Hill, District- Papumpare, Itanagar, Arunachal Pradesh- 791111 and (iii) the Inspector General of Command Office, ITBP Eastern Command, A-14, 6th Floor, Game Village, Guwahati, as respondent Nos. 6, 7 and 8 respectively in the connected WP(C) No. 7425/2025.

Learned counsel appearing for the applicant contends that inadvertently the proposed respondents were not impleaded while filing the instant petition, however, their presence is necessary and essential for effective adjudication of the writ petition.

Having heard the learned counsel appearing for the parties and having perused the averments made in the interlocutory application, the following respondents are impleaded as party respondent Nos. 6, 7 and 8 respectively in the connected WP(C) No. 7425/2025:

- i) The Director General, ITBP, Delhi Headquarter, Block No. 2, CGO Complex, Lodhi Road, New Delhi-110003.

ii) The Inspector General North-East Frontier Headquarters, ITBP, Itanagar, P.O.-Khating Hill, District- Papumpare, Itanagar, Arunachal Pradesh- 791111.

iii) The Inspector General of Command Office, ITBP Eastern Command, A-14, 6th Floor, Game Village, Guwahati.

Accordingly, the interlocutory application stands disposed of.

Let an amended cause titled be submitted before the Registry for doing the needful within a period of 2 (two) days from today.
