Since LCR has been received, the matter be listed for hearing.

In the interim, if the petitioner has not yet been detained on the strength of the order dated 09.11.2018 passed in F.T.9th (BPT) Case No.303/2017 passed by the learned Member, Foreigners' Tribunal 9th, Barpeta, Assam, may not be detained/arrested and deported from India. However, the petitioner shall appear before the Superintendent of Police (Border), Barpeta within 15(fifteen) days from today, who may obtain necessary information and documentation as required under the rules from the petitioner for securing his presence. On such appearance, the petitioner shall furnish a bail bond of ₹ 5,000/- (Rupees five thousand) with one local surety of the like amount to the satisfaction of the said authority, whereafter, the petitioner shall be allowed to remain on bail. The concerned Superintendent of Police (Border) shall also take steps for capturing the fingerprints and biometrics of the iris of the petitioner, if so advised. The petitioner also shall not leave the jurisdiction of Barpeta district without furnishing the details of the place of destination and necessary information including contact number to the Superintendent of Police (Border), Barpeta.
