Heard Shri R.S. Mishra, learned counsel for the petitioner.

As per the facts projected, the petitioner was engaged in business of execution of work contracts with the respondent no.1. However, in the year 2021, the GST registration was cancelled due to situation beyond the control of the petitioner including the outbreak of the COVID-19 pandemic. The GST was subsequently restored.

However, in the meantime, the bills of the petitioner though released, was done by withholding the GST component. The grievance of the petitioner is that the amount should be released with undertaking that the necessary challan would be deposited to the respondent no. 1 within a very short time.

Let notice be issued, returnable on 10.03.2026.
