Heard Mr. M.K. Choudhury, learned senior counsel assisted by Mr. M. Sarma, learned counsel for the petitioners and Mr. P. Gogoi, learned standing counsel for all the respondents.

2. In this petition, under Article 226 of the Constitution of India, the petitioners have prayed for issuing direction to the respondent authorities to regularized their services pursuant to their absorption under Regulation 3(f), vide notification dated 22.01.2025, issued by the respondent authorities and also issue direction not to place/recruit candidates pursuant to the advertisement(s) dated 30.12.2024, in the permanent vacant sanctioned posts currently occupied by the members of the petitioner No. 1 society and further, to direct the respondent authorities to grant regular scale of pay attributable to Lecturer(s) to the members of the petitioner No. 1 society, absorbed under Regulation 3(f) as per notification dated 22.01.2025.

3. Perused the petition as well as the documents placed on the record.

4. Let notice be issued to the respondents, returnable in 4 weeks, by registered post with A/D and also by usual process. As Mr. Gogoi has appeared and accepted notices on behalf of all the respondents, no formal notice is required to be issued. However, extra requisite copy of the petition be furnished to him during the course of the day.

5. List the matter after 4 (four) weeks.

6. The interim prayer of the petitioners will be considered on the next

date.
