Ahmed, learned counsel for the petitioner, Mr. A Ali, learned counsel for the Election Commission of India, Mr. UK Nair, learned senior counsel for the State of Assam appearing for the Foreigners Tribunal and Border Affairs as well as Ms. G Sarma, learned counsel for the authorities under the Union of India.

Issue notice to the respondents except the respondent No.6 returnable in six weeks.

Extra copies of the writ petition be furnished to the respective learned counsel within three days.

Call for the LCRs of FT. Case No.218/2015 from the Foreigners Tribunal, Kamrup(M) No.2, Guwahati.

In the meantime, the petitioner shall neither be detained nor be deported. The petitioner shall submit two separate surety bonds from two prominent persons of her village or a security from an appropriate Government official to the satisfaction of the Deputy Commissioner of Police City, Guwahati to ensure continuous presence of the petitioner as and when required by the authorities, who shall also satisfy itself regarding the authenticity and acceptability of the sureties.

List the matter after six weeks.
