1. Learned counsel Mr. M. Talukdar is present for the applicant and has prayed for withdrawal of the amount of Rs. 12,90,760/- deposited before the Registry of this Court.
2. Learned counsel Mr. R. Goswami is present for the respondents and has submitted that withdrawal may be allowed on submission of indemnity bond by the claimant/applicant No. 3.
