Heard Dr. G.J. Sarma, learned counsel appearing for the writ petitioner.

Aggrieved by the order dated 06-12-2022, issued by the Deputy Commissioner, Kamrup (M) at Guwahati rejecting the prayer made by the petitioner for her re-engagement as M.R. Worker, this writ petition has been filed.
