- 1.** Heard Mr. R. C. Paul, learned counsel for the appellant.
- 2.** This appeal under Section 173 of the Motor Vehicles Act, 1988 has been preferred by the New India Assurance Company Limited impugning the judgment and award dated 28.11.2025 passed by the Motor Accident Claims Tribunal, Golaghat, in MAC Case No. 218/2018 whereby an amount of Rs.6,20,368/- has been directed to be paid by the present appellant to the claimants along with interest at the rate of 9% per annum.
- 3.** After considering the grounds taken in the memo of appeal and also considering the submissions made by the learned counsel for the appellant, this appeal is admitted.
- 4.** Issue notice to the respondents.
- 5.** Call for the records of MAC Case No. 218/2018 from the concerned tribunal.
- 6.** The appellant shall take steps for issuance of notice upon the respondents by speed post as well as by usual mode within seven days from the date of this order, returnable on 8<sup>th</sup> of May, 2026.
