Heard Mr. S. Banik, learned counsel for the petitioner and Mr. S. K. Talukdar, learned Standing counsel, Co-operation Department for the respondent Nos. 1, 2 and 3.

In a writ petition preferred by the Azad Samabai Samittee being WP(C) No.1415/2022, this Court on 02.03.2022 passed an order disposing of the said writ petition directing the Assistant registrar of Co-operative Societies, Barpeta to consider the Resolution Nos. 2 and 3 dated 10.01.2022 and 16.09.2021, respectively, passed by the Board of Directors, Azad Samabai Samittee against the petitioner Samabai Samittee in which he was the Secretary, and to pass a reasoned order by the concerned ARCS, Barpeta within a period of 3(three) weeks from the date of receipt of the certified copy of the said order to be submitted by the petitioner Society.

Petitioner herein have challenged the said Resolution No.2 dated 10.01.2022 resolved by the present respondent No.4 Society i.e., the petitioner Society of WP(C) No.1415/2022 relating to termination of his service from the said Samabai Samittee.
