- 1.** Heard Ms. R. D. Mozumdar, the learned counsel for the appellant.
- 2.** This appeal under Section 173 of the Motor Vehicle Act, 1988 has been preferred by the Oriental Insurance Company Limited impugning the judgment and award dated 01.12.2025 passed by the Motor Accident Claims Tribunal, Cachar, Silchar in MAC Appeal No. 421/2020, whereby the appellant was directed to pay a compensation amount of Rs. 19,10,602/- along with an interest of 9 % per annum to the claimants/respondent and thereafter, recovery of the same from the owner of the offending vehicle.
- 3.** I have gone through ground stated in the Memo of Appeal and have considered the submissions made by the learned counsel.
- 4.** This appeal is admitted.
- 5.** Issue notice to the respondent.
- 6.** Call for the records of the MAC Appeal No. 421/2020 from the concerned Tribunal.
- 7.** The Registry shall take steps for requisitioning the aforesaid

records.

8. The appellant shall take fresh steps for issuance of notice upon the respondents by the speed post as well as by usual mode within seven days from the date of this order, returnable on 24.04.2026.
