Heard Mr. G. N. Sahewalla, learned Senior Counsel assisted by Mr. M. Sahewalla, learned counsel for the petitioner.

By order dated 24.04.2026, this Court directed the State respondents to file an additional affidavit, as certain aspects of the case were not clear from the affidavit filed by the Deputy Commissioner, Cachar.

Today, Ms. N.
