Heard Ms. A. Biyani, learned counsel appearing on behalf of Mr. R.K. Bhatra, learned counsel for the applicant/appellant.

This is an application for stay of the judgment and award dated 28.08.2023, passed by the learned Member, MACT, Sonitpur in MAC Case No.32/2019, till disposal of the connected appeal.

However, it is submitted by Ms. Biyani, learned counsel that they are ready to deposit 50% of the awarded amount along with interest accrued till date, before the Registry of this Court.
