Heard Mr. A.Y. Choudhury, learned counsel for the applicants. Also heard Ms. A. Borthakur, learned counsel for the opposite party No. 2 and Mr. P.K. Borah, learned counsel for the opposite party No. 3.

2. This is an application for impleadment of Mr. Narayan Konwar, Secretary to the Government of Assam, Department of School Education as alleged contemnor No. 4 in the connected Cont.Cas(C)/96/2024 as the earlier incumbent had expired.

3. Having considered that the earlier incumbent had expired and that Mr. Narayan Konwar is the current Secretary to the Government of Assam, Department of School Education, and as agreed to by learned counsel for both the parties, this Court deems it appropriate to allow this application by permitting the applicants to implead Mr. Narayan Konwar, Secretary to the Government of Assam, Department of School Education as contemnor No. 4 in the connected Cont.Cas(C)/96/2024.

4. Accordingly, Mr. Narayan Konwar, Secretary to the Government of Assam, Department of School Education is allowed to be impleaded as alleged contemnor No. 4 in the connected Cont.Cas(C)/96/2024.
