Heard Shri R. Dubey, learned counsel for the petitioner, who is primarily aggrieved by non-consideration of his proposal submitted on 23.01.2026 for One Time Settlement (OTS) by the respondent no. 1 Bank.

It is contended on behalf of the petitioner that there are clear guidelines by the Reserve Bank of India in the form of circular as per which, there has to be a due consideration.

This Court has, however, noticed that the present action is connected to a SARFAESI proceeding.

Be that as it may, let notice be issued returnable on 01.04.2026.

Shri N. Goswami, learned State Counsel, Assam accepts notice on behalf of the respondent no. 3.

Let extra copy of the writ petition be served upon the learned State Counsel.

Steps for service of notice upon the respondent nos. 1, 2 and 4 be taken by speed post with A/D.

Steps within 2 working days.

Additionally, the petitioner is permitted to take *dasti* service upon the respondent nos. 1, 2 and 4 which is, however, should be routed through the Registry of this Court. In the *dasti* notice, the next date of the case should be clearly reflected. Prior to the next date fixed, an affidavit in proof of such *dasti* service should be filed.

The maintainability of this writ petition is, however, be kept open.
