**2.** The petitioner is claiming exemption from the routine transfer on the ground that his wife suffers from psychiatric ailment and requires constant monitoring and care. His daughter is also appearing for the NEET examination which is scheduled to be held in May, 2026 and the mother of the writ petitioner also recently expired.

**3.** It is the submissions that the petitioner being the only caregiver, at this stage if the transfer order is given effect to, he will face immense difficulty on his personal front, in which the respondents cannot be oblivious. Under such circumstances, the present writ petition has been filed.
