Heard Mr. M. A. Sheikh, learned counsel, appearing for the petitioners. Also heard Mr. B. Das, learned Standing Counsel, APDCL, and Mr. N. Das, learned Government Advocate, appearing on behalf of the respondents represented by him.

2. The petitioners in the present writ petition has projected that the respondent authorities under the land policy in place had settled the land, in question, with the petitioners and a patta was also issued, in respect, thereof, to the petitioners. It is submitted that during the subsistence of the said settlement, the respondent authorities had proceeded to evict the petitioners from the said plot of land on 06.01.2026. It is further projected that thereafter the patta was cancelled and the land records were corrected with the inclusion of the name of the APDCL, therein. Mr. M. A. Sheikh, has submitted that the said action were so taken without any notice being issued to the petitioners.

3. Mr. M. A. Sheikh, has further submitted that after the eviction, the petitioners are continuing to reside in the said plot of land by construction of temporary sheds.

4. Mr. N. Das, submits that he would complete his instructions in the matter by 30.03.2026.

5. Accordingly, Registry to list this matter again on **30.03.2026**.

6. Till the next returnable date, status quo as on date shall be maintained. The said interim directions passed in the matter directing

the parties to maintain status quo in the matter, shall be re-considered on the next date of listing, upon Mr. N. Das, completing his instructions.
