ORDER

Petitioner-in-person Mr. Santosh Singh is present who has filed this application under Section 115 of the Code of Civil Procedure 1908 read with Article 227 of the Constitution of India with prayer to pass an order directing the learned Civil Judge, Hojai, Assam to ensure expeditious progress of Title Suit No. 23/2016 by completing the examination of the defendant's witness within a fixed time frame, preferably within a period of six months from the date of communication of this order. A prayer is also made to direct the learned Civil Judge, Hojai, Assam not to grant adjournments on trivial matters, and to pass any other such orders as this Court deems fit and appropriate.

2. It is submitted that the Title Suit No. 50/2015 and Title Suit No. 23/2016 have been pending in the trial court. It is also submitted that there appears to be no probability of disposal of the title suits within a short period of time. Both the cases have been procrastinated by the court. The petitioner is the plaintiff of both the title suits and is suffering immensely due to the procrastination of both the title suits. This has impelled the petitioner to approach this Court for a speedy and expeditious disposal of both the title suits.

3. I have considered the submission of the petitioner with circumspection.

4. It is true that the title suits have been pending since the year 2015-2016 and thereby, the learned trial court is directed to make every endeavor to dispose of both the title suits expeditiously.

5. In terms of the above observations, this petition stands disposed of.
