**ORDER**

**Date : 01.04.2026**

This is a common order for these three Interlocutory Applications.

2. Heard Mr. B K Mahajan, learned counsel appearing for the applicants in IA(Crl.)/341/2026 & IA(Crl.)/43/2026 as well as Mr. R P Hazarika, learned counsel appearing for the applicants in IA(Crl.)/116/2026. Also heard Mr. K K Das, the learned Additional Public Prosecutor for the State of Assam.
3. This is an application under Section 430 (2) of the BNSS, 2023 praying for suspension of sentence and for allowing the applicants to go on bail.
4. I have considered the submissions made by the learned counsel of both sides. I have also gone through the evidence available in the record.
5. The prayer of the applicants are partly allowed.
6. The sentence imposed upon the applicants, namely, **Sri Raju Singh, Sri Bablu Singh, Sri Jay Kishan Singh @ Jaikishan Prasad, Sri Jatin Munda, Sri Mahesh Munda & Sri Biki Munda** by the learned **Sessions Judge, Sonitpur, Tezpur** in **Sessions Case No.120/2018** shall remain stayed till disposal of the connected appeals.
7. The applicants, namely, **Sri Raju Singh, Sri Bablu Singh, Sri Jay Kishan Singh @ Jaikishan Prasad, Sri Jatin Munda, Sri Mahesh Munda & Sri Biki Munda** are allowed to go on bail of **₹25,000/- (Rupees Twenty Five Thousand)** each with sureties of like amount to the satisfaction of the learned **Sessions Judge, Sonitpur, Tezpur**.
8. The prayer for bail of the applicant, namely, **Sri Akash Munda @ Baishya** stands **rejected**.
9. With the aforesaid direction, all the three Interlocutory Applications are disposed of.
