1. Heard Mr. B Chetri, learned counsel for the applicant. Also heard Mrs. S Sarma, learned Junior Government Advocate representing the respondent Nos. 2 and 4.
2. This Interlocutory Application has been filed for condonation of the delay of 21 days in filing the connected appeal against the judgment dated 06.01.2026 passed by a learned Single Judge of this Court in WP(C) No. 2294/2024.
