Heard Mr. B.M. Deka, learned counsel for the petitioner.

By filing this petition, the petitioners have put to challenge the notices dated 17.06.2025, 19.11.2025 and 27.11.2025 issued by the Director of Elementary Education, Assam, whereby, it is provided that all the candidates, who have successfully submitted their online application against the Director of Elementary Education pursuant to the advertisement for recruitment of regular teachers of LP and UP Schools are required to submit their details of HSLC examination and NIOS–UDISE (for whom it is applicable), failing which, would lead to cancellation of their candidature.

It is the contention of the petitioners that the requirement of UDISE was not mandatory as on 2017. The petitioners having been completed their 18 months diploma in Elementary Education from National Institution of Open School, the requirement of submission of NIOS-UDISE by the authorities would cause prejudice to the petitioners from participating in the recruitment of teachers of LP and UP Schools.

Issue notice, returnable by 4 (four) weeks.

Since Mr. S.M.T. Chistie, learned counsel has entered appearance and accepted notice on behalf of respondents No.,1, 2 and 3, no formal notice is required to be issued to the said respondent. However, requisite extra copies of the writ petition be furnished to the learned counsel for the respondents within 2 (two) working days.

The learned counsel for the petitioner to take steps for service of notice upon the respondents

No. 4 and 5 by speed post as well as usual process within 3 (three) working days.
