Heard Mr. A. A. R. Karim learned counsel for the petitioners.

2. The petitioners are challenging the recovery of the Risk and Hardship Allowances (R&HA), which were earlier granted to the petitioners. Being aggrieved, the present writ petition has been filed.

3. It is submitted that similar other writ petitions have been filed by other similarly situated persons which are pending before the Court.

4. Considering the submissions made by the learned counsel for the petitioners, let Notice be issued, returnable by 6 (six) weeks.

5. Mr. B. Deka, learned CGC appears and accepts notice on behalf of all the respondents. Therefore, notices are waived. Extra copies be furnished to him within 1 (one) week from today.

7. In the interim, it is directed that until further orders there shall be no recovery of Risk and Hardship Allowances (R&HA) from the writ petitioners.
