Heard Mr. A.K. Sarma, learned counsel for the petitioner, who submits that the petitioner, who was an Anganwadi Helper, had filed W.P. (C) No. 6669/2016, praying for promotion to the post of Anganwadi worker. However, Advertisement dated 05.10.2016 had been issued by the respondents for filling up the post of Anganwadi worker in No. 73 Borbila Part II Anganwadi Centre.

He submits that this Court vide order dated 07.11.2016, passed in W.P.(C) No.6669/2016, had stayed the Advertisement dated 05.10.2016. However, the State respondents have issued a fresh Advertisement dated 15.02.2019, calling for candidates to fill up the post of Anganwadi worker in the same No. 73 Borbila Part II Anganwadi Centre.

The petitioner's counsel also submits that no appointment has been made to the post of Anganwadi worker in pursuance to the Advertisement dated 15.02.2019.

Issue notice, returnable in 4(four) weeks.

Mr. D. Nath accepts notice on behalf of all the respondents.

List the matter after 4(four) weeks.

In the interim, the State respondents are directed not to give any effect to the Advertisement dated 15.02.2019 in respect of No. 73 Borbila Part II Anganwadi Centre.
