Heard Mr. A. Hussain, learned counsel for the petitioner.

The petitioner in the present writ petition has raised a grievance with regard to the freezing of the bank account maintained with the State Bank of India Dakhin Ganakgari Branch, Barpeta i.e. the respondent No. 3.

It is projected that the petitioner, herein, is a Constable (GD) with the Central Industrial Security Force and the said account is a salary account of the petitioner.

Considering the same the learned counsel for the petitioner is directed to serve copy of the present writ petition to the respondent No. 3 by way of 'dasti' mode to be routed through the Registry of this Court. On effecting such service, the petitioner shall file an additional affidavit.

On the next date of listing the Branch Manager of State Bank of India, Dakhin Ganakgari Branch, Barpeta shall apprise this Court as to why there is total debit freeze imposed upon the said account of the petitioner.
