Heard Mr. AK Sarma, learned counsel for the applicants and Mr. A Dutta, learned CGC for the opposite parties/respondents.

This Interlocutory Application has been filed seeking impleadment of the North Eastern Council (NEC), Shilling and the Principal Accountant General, Assam as the party respondents. It is submitted that in the accompanying writ petition being WP(C) No.2951/2025 the claim made by the writ petitioners are in respect for inclusion of their names under the old pension scheme. Accordingly, it is submitted that the North Eastern Council (NEC), Shilling and the Principal Accountant General, Assam would be necessary parties and therefore by filing this Interlocutory Application impleadment of their names as the party respondents no. 5 & 6 have been sought for.

Learned CGC appearing for the opposite parties/respondents does not object to the prayer made.

Considering the submissions made and considering the claims made by the writ petitioners in the writ petition that they are seeking inclusion their

names under the old pension rules, this Court is of the view that the prayer made in this Interlocutory Application be allowed.

Accordingly, the Interlocutory Application stands allowed and disposed of.

The North Eastern Council (NEC), Shilling and the Principal Accountant General, Assam be arrayed as the respondent nos. 5 & 6 in the writ petition being WP(C) No.2591/2025. The petitioner will file amended cause title before the Registry within a period of 3 (three) weeks from today.
