Heard Mr. H.A. Laskar, learned counsel for the petitioners; Ms. S. Kataki, learned Standing Counsel, Election Commission of India [ECI] for the respondent nos. 1, 2, 4 & 5; and S.R. Baruah, learned Junior Government Advocate, Assam for the respondent no. 3.

The petitioners, thirteen in nos., have claimed that they are residents of Village – Hatairbond, P.O. – Katomoni Bazar, District – Sribhumi, Assam under the territorial limits of No. 125 Patharkandi Legislative Assembly [LAC]. The petitioners have projected that their names have been duly enrolled in the Electoral Roll published on 10.02.2026 under Polling Station No. 191. But, when they made search in the official voters' service portal maintained by the ECI, they could not find their names in the digital electoral database.

Ms. Kataki, learned Standing Counsel, ECI is to obtain instructions so as to place it before the Court whether in the digital electoral database the petitioners' names are incorporated or not.

To facilitate the same, Mr. Laskar, learned counsel for the petitioners has undertaken to furnish the Electors Photo Identity Card [EPIC] numbers to Ms. Kataki, learned Standing Counsel, ECI during the course of the day.
