**[1]** Heard Ms. M. Saikia, the learned counsel for the applicant/insurance company.

**[2]** This interlocutory application has been filed by the applicant/insurance company praying for refund of the statutory deposit of Rs. 25,000/- filed by the applicant/insurance company at the time of filing of the MACAppeal No. 338/2018.

**[3]** The learned counsel for the applicant has submitted that the aforesaid appeal has been disposed of on 20.02.2026 by this court. However, no order as regards refund of the statutory deposit was made in the

judgment passed by this court.

**[4]** After going through the judgment passed on 20.02.2026, in MACAppeal No. 338/2018, it appears that though order for refund of the statutory deposit was made therein.

**[5]** Hence, this interlocutory application is allowed.

**[6]** The Registry is directed to refund the statutory deposit of Rs. 25,000/- which was made by the present applicant/insurance company at the time of filing of the MACAppeal No. 338/2018 after proper verification.

**[7]** The learned counsel for the applicant has further submitted that though at the time of filing the MACAppeal No. 338/2018, the name of the applicant/insurance company was Reliance General Insurance Co. Ltd., however, the name has now been changed to Indusind General Insurance Co. Ltd. and, therefore, the applicant with its new name may be allowed to withdraw the statutory deposit.

**[8]** The prayer is allowed.

**[9]** This interlocutory application is, accordingly, disposed of.
