ORDER

Date : 02.12.2025

Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Perusal of the recent office note dated 02.12.2025 reveals that notices in respect of the respondent Nos. 6 & 7 were issued through *dasti mode* and registered post with A/D on 02.04.2022.

However, in respect of the respondent No. 6, it appears that the learned counsels have already entered appearance on behalf of the said respondent by filing Vakalatnama. As such, it may be said that **service in respect of the respondent No. 6 has been completed.**

Now, in respect of the notices issued to the respondent No. 7, it has been observed as follows:—

In respect of the notice issued through dasti mode:— *The petitioner has not yet filed any affidavit regarding service of said dasti notice upon the respondent No. 7.*

In respect of the notice issued through registered post with A/D:— *In this regard, it appears that neither the A/D card nor any un-served notice has been received in respect of the above mentioned notice issued to the respondent No. 7. Further, it appears that the postal track consignment report regarding the aforesaid notice is also not available at the Indian Post Website.*

In view of the observations made above, the petitioner is hereby directed to take fresh steps for service of notice upon the respondent No. 7 by way of speed post mode, in terms of the **Notification No. 85 dated 15th October, 2025 (at Flag-'N')**. The said steps shall be

taken within 7 (seven) days from the date of the said order.

Further, the petitioner is also directed to take requisite steps for filing necessary affidavit reflecting service status of *dasti notice* dated 02.04.2022 issued to the respondent No. 7.

Let the matter be listed again before the Lawazima Court in the first week of January, 2026.
