ORDER

Case taken up before the Lawazima Court.

None appears on behalf of the petitioner.

Perused the records.

Upon a careful perusal of the record, it is observed that the matter was previously listed before the Lawazima Court on 02.12.2025. By the order passed on that date, the petitioner was directed to take fresh steps for service of notice upon the respondent No. 7 via speed post mode, within 7 (seven) days from the date of the said order.

Vide the said order, the petitioner was further directed to file an affidavit reflecting the service status of the dasti notice dated 02.04.2022 issued to the said respondent.

But so far, the petitioner has neither taken fresh steps for service of notice upon the respondent No. 7 nor filed any affidavit regarding the dasti notice dated 02.04.2022 issued to the said respondent.

In view of the above, the petitioner is granted further one week time to comply with the order dated 02.12.2025, failing which, the A.O.(J) of the concerned section is directed to place the matter before the Hon'ble Court.
