3. The applicant as the writ petitioner has preferred the writ petition, W.P.C. no. 1306/2026 assailing a cancellation Notice dated 30.12.2025 and a re-tender Notice dated 08.01.2026. It is stated that the proposed party respondent was the authority who had issued the impugned re-tender Notice and as such, he would be a necessary party in the proceedings

4. Mr. Gogoi, learned Additional Advocate General, Assam appearing for all the opposite parties has not opposed the prayer for impleadment.

5. As the proposed party respondent is found to be a necessary party in the accompanying writ petition, the instant interlocutory application stands allowed.
