Heard Mr. M.H. Ahmed, learned counsel for the petitioner. Also heard Mr. P. Borthakur, learned Addl. P.P. appearing for the State respondent.

2. This is an application under Section 482 of BNSS, 2023, has been filed by the petitioner, namely, **Abu Bokkor Siddique @ Md. Abu Bakkar Siddique**, seeking pre-arrest bail in connection with Bihpuria P.S. Case No.45/2026, registered under Sections 126/117(2)/118(1)/3(5) of the BNS, 2023.

3. The informant is one Md. Harunar Rasid, who is an Assistant Teacher of one Gosaipukhuri Azad M.E. School and he has made the allegation naming the petitioner and another lady Assistant Teacher that on 20.02.2026, he visited the school along with documents for registering his name for teachers post on a portal and subsequently, on the next day, when he was returning, the petitioner caught hold of him and both the accused persons assaulted him, causing injuries.

4. The learned counsel for the petitioner drawing attention to Annexure-5 submits that it is a letter written by four teachers of the same school, including the informant about being deprived by the petitioner herein in applying through the portal of the school in the context of the school provincialization being under process.

5. Call for the case diary.

6. However, I am of the considered view that in the circumstances, the petitioner, as stated to be the headmaster of the said school, should be given an opportunity to record his statement.

7. Accordingly, in such view of the matter, in the **interim**, in the event of his arrest of the petitioner, named above, is hereby allowed to go on pre-arrest bail of **Rs. 30,000/-** with one surety of like amount to the satisfaction of the arresting authority, and subject to the following conditions that:-

(i) That the accused petitioner shall co-operate with investigation and not

cause any harm, harassment or intimidation to the informant.

8. Violation of any bail conditions will entail cancellation of the bail.
9. List this matter again on **11.05.2026**.
