Heard Mr. H. Baruah, learned counsel for the petitioner.

Aggrieved by non-consideration of her case for promotion and also due to non-payment of arrear salary, the writ petitioner, who is presently serving as an UDA in the head of Assam Plain Tribes Development Limited, Dispur, Guwahati, has approached this Court seeking a writ of mandamus.

Mr. B. Gogoi, learned Standing Counsel, Finance Department, Assam appearing for the respondent No.2 as well as Mr. K. Kalita, learned counsel appearing for the respondent No.4 have prayed for some time to obtain instruction. Similar is the prayer of Mr. R.
