Heard Mr. T Deuri, learned counsel for the petitioners.

The petitioners are working as Artificial Insemination Technicians (AITs), who are temporality engaged under the Schemes of the Animal Husbandry and Veterinary Department, Government of Assam. By a notice issued in November, 2025, the respondent No. 4, namely the Chief Executive Officer, Assam Livestock Development Agency has invited application from interested persons in respect of 1000 such posts spread across 33 districts in the State of Assam. It is the apprehension of the petitioners that if this process of engagement in pursuance to notice dated 18.11.2025 is carried on, the continuance and/or further continuance in the said post by the writ petitioners may not be considered by

the respondent authorities. There is no clarity in the notice that these 1000 posts are over and above the posts in which the writ petitioners are working. Therefore, the apprehension is expressed.

Having heard learned counsel for the parties, let Notice be issued, returnable in four weeks.

Since Ms. S Baruah, learned Government Advocate appears for the respondent No. 1; Mr. T.C. Chutia, learned Addl. Senior Government Advocate appears for the respondent No. 2 and Ms. M.M. Katakya, learned Standing Counsel, Animal Husbandry and Veterinary Department appears for the respondents No. 3 to 6, Notices are waived. However, extra copies be furnished within one week from today.

The respondents will obtain the required instructions and file necessary affidavit.

Matter be listed again on 06.05.2026.

Till the next date of listing, the service condition of the writ petitioners shall not be altered to their detriment without leave of the Court.
