Perused the records.

Perusal of the instant case record reveals that notice was issued to the respondent Nos. 1 to 11 by registered post with A/D as well as by way of *dasti mode* on 14.08.2025 & 21.05.2025 respectively.

Now, in respect of the aforesaid notices issued to the respondent Nos. 1 to 11, it has been observed as follows:—

In respect of the notice issued through dasti mode:— In this regard, it appears that the petitioner has not yet filed any affidavit regarding service of *dasti notice* issued to the respondents mentioned above.
