Heard Mr. D.P. Borah, learned counsel for the writ petitioners. Perused the averments made in the writ petition.

The petitioners claim to be candidates belonging to the Tea Tribe community in Assam, which is reckoned as an OBC/MOBC category within the State. The grievance of the petitioners is that although they had qualified in the PET, PST and Medical test by securing the requisite cut off marks, the respondents are refusing to allow them to appear in the written test to be held on 06/04/2025. Hence, this writ petition.

Since the petitioners are complaining that they are not being allowed to participate in the written test despite being eligible, Mr. T.C. Chutia, learned Additional Senior Government Advocate, Assam, to obtain written instruction and respond to the said allegation, on the next date fixed.

List this matter again on 04/04/2025 for motion, as a fixed item.
