- 1.** Heard Mr. N. K. Murry, learned counsel for the petitioner. Also heard Mr. K. Baishya, learned Additional Public Prosecutor for the State of Assam.
- 2.** This is an application under Section 528 read with Section 438 and 442 of the Bharatiya Nagarik Suraksha Sanhita, 2023, in respect of PRC Case No.1334/2018, pending in the Court of the learned Judicial Magistrate First Class, Kamrup (Metro) at Guwahati.
- 3.** During the COVID-19 period, the petitioner, Prodip Mazumder @ Pradip Mazumdar,

was unable to appear before the High Court. Consequently, the Trial Court directed issuance of a Non-Bailable Warrant of Arrest (NBWA) against him.

4. I have considered the submissions made by the learned counsel for both sides.

5. The prayer of the petitioner is allowed.

6. All orders directing issue of Non-Bailable Warrant of Arrest (NBWA) against the present petitioner are set aside.

7. The petitioner, Prodip Mazumder @ Pradip Mazumdar is directed to appear before the Judicial Magistrate First Class, Kamrup (Metro) at Guwahati in connection with PRC Case No.1334/2018 on 07.04.2026 and on his appearance, the petitioner shall be released on fresh bail of Rs.20,000/- with a surety of like amount to the satisfaction of the learned Judicial Magistrate First Class, Kamrup (Metro) at Guwahati.

8. With the aforesaid direction, this Criminal Petition stands disposed of.
