Mr. N. Das, learned Government Advocate, appearing for the State respondents, submits that the petitioner has already filed an application before the jurisdictional District Commissioner, Nalbari, for the death occasioning in respect of her husband on account of a vehicular accident on 01.09.2024. He submits that the said application in view of the fact that the offending vehicle has not been identified, is now required to be processed in terms of the notification dated 31.10.2023.

Mr. N. Das, prays that he be granted till 24.04.2026, to complete his instructions and apprise this Court about the steps taken in the matter by the jurisdictional District Commissioner, Nalbari, after receipt of the said application dated 25.10.2024 from the petitioner, herein.

It is provided that, in the event, the jurisdictional District Commissioner, has not processed the said application dated 25.10.2024 received from the petitioner, herein, the jurisdictional District Commissioner, shall in the event the claim of the petitioner confirms to the applicable norms, process the same strictly in accordance with the notification dated 31.10.2023, and apprise this Court, on the next date of listing, about the developments taking place in the matter.

Accordingly, Registry to list this matter again on **24.04.2026**.
