Heard Mr. H.K. Das, learned counsel for the applicant.

Perused the averments made in the application.

By assailing the orders dated 19-02-2025 as well as consequential order enclosed therein, permitting recovery of a sum of Rs. 10,17,201/- from the applicant, this I.A. has been filed *inter-alia* contending that the impugned order(s) have been issued during the pendency of this writ petition without obtaining leave of this Court and therefore, those are unsustainable in law.

It is also the submission of Mr. Das that the impugned orders are not only illegal but based on such orders, the authorities have also stopped the provisional pension paid to the applicant since the month of February, 2025. Hence, an interim direction has been prayed for from this Court for releasing the provisional pension of the applicant as well as for stay of operation of the orders assailed in this I.A.

Ms. M. Bhattacharjee, learned Addl. Sr. Govt. Advocate, Assam and Mr. C. Baruah, learned standing counsel, AG(A&E), Assam have both prayed for posting this matter again on 10-04-2025 so as to enable them to obtain preliminary instruction responding to the

prayer made in the I.A.

In view of the above, let this I.A. be listed again on 10-04-2025, as fixed item, by reflecting the names of learned counsel for all the parties in the cause list.
