Heard Mr. D. Baruah, learned counsel for the petitioners.

2. Issue notice, returnable within 2(two) weeks.
3. Mr. J. Handique, learned Standing Counsel, Revenue Department accepts notice on behalf of the respondent Nos.1, 2 & 3.
4. Ms. B. Bhuyan, learned Standing Counsel, BTAD accepts notice on behalf of the respondent Nos.4 & 5.
5. The case of the petitioners is that the petitioners had been earlier selected for undergoing 6(six) months Recorders Certificate Class Course Training at Assam Survey & Settlement Training Centre, Rajah Nagar, Dakhingaon, Guwahati and their names were

forwarded by the Office of the BTC vide orders dated 19.07.2018 and 30.08.2018.

6. However, the petitioners could not be accommodated as they were beyond in the capacity in the said Centre. However, they were assured that they will be given training in the next phase.

7. In that view of the matter, till the next date, no fresh candidates from BTC may be recommended other than the petitioners for undergoing the aforesaid training.

8. The State authorities will also consider inclusion of the 68 petitioners in the forthcoming training session in terms of the earlier recommendation by the BTC Authorities.
