2. By filing this application under Order XXII Rule 3 read with Section 151 CPC, the applications are praying for substitutions of their names as the legal representatives of the sole appellant, Smt. Lila Bala Thakuria who had died on 05.01.2026.

3. It is seen that the present application has been filed on 02.04.2026, accordingly, it is within the period of limitation prescribed for substitution which is 90 (ninety) days under Article 120 of the schedule to the Limitation Act, 1963.
